

Boiling Water: Family Law Practice Post-Pandemic by <u>Steven N. Peskind</u>

The late David Foster Wallace told the following parable about living unaware:

There are these two young fish swimming along, and they happen to meet an older fish swimming the other way, who nods at them and says, "Morning, boys. How's the water?" And the two young fish swim on for a bit, and then eventually one of them looks over at the other and goes, "What the hell is water?" According to Wallace, "the point of the fish story is merely that the most obvious, important realities are often the ones that are hardest to see and talk about..." Like the fish in the story, our routines and the daily hustle of our practice blinds us to the big picture of what's going on around us. In this season of reflection, I want to pause to take the water temperature.

My observations:

I'm sure everyone's experience differs, but here's what I've observed since the advent (and hopeful taming) of the pandemic. Clear trends have emerged.

Court time is less available now than pre-pandemic. This means that issues we considered time sensitive, or even critical before March of 2020, are now put off for months. Those matters casually presented as emergent are now yawned at by judges. I appear before a judge who I greatly admire, who now coyly asks lawyers presenting emergency motions, "where's the blood?" No blood...no relief.

Maybe this is a good thing-training the puppies to stay on the paper. Good or bad, it's now a reality and lawyers need to work things out without the immediate help of mommy or daddy in their black robes. Unfortunately, without a practical or cooperative adversary, this becomes a frustrating and often insurmountable challenge.

Another trend I've observed is that fewer lawyers diligently work to resolve cases. Whether the stress of modern life just debilitates them, or other cultural factors are at play, stuff is just not getting done.

Divorce, Military Pension and the 10/10 Rule: Questions & Answers by Mark E. Sullivan Author of the The Military Divorce Handbook **Rachel:** I need some information about my divorce case. Will it help if we try to speed up the granting of a divorce, so that my soon-to-be ex won't be married to me for 10 years? And what's this 10/10 Rule I keep hearing about?

Attorney: For your husband to get a garnishment for a share of your retired pay as property division, there has to be a court order which shows compliance with the "10/10 Rule." That means that you have to be

Rachel: As you know, we separated two years ago. That counts for something, right? We don't meet the 10/10 Rule, the way I calculate it. Attorney: The Rule's requirements involve the termination of marriage, and that occurs on the date of divorce. It is not the date of separation, or some other date associated with the marriage, such as the date of irretrievable breakdown of the marriage, or the date of commencement of the divorce case.

Dividing a military pension in a divorce case sometimes involves a term unfamiliar to clients and attorneys – the "10/10 Rule." Judges, lawyers and clients may have heard rumors about some requirement as to 10 years of military service concurrent with 10 years of marriage. And they may have heard that this somehow affects the division of military retired pay. Let's listen in on a conversation regarding this subject between Staff Sergeant Rachel Roe, an Army Reservist, and her lawyer:

married to your husband for at least ten years during at least ten years of service toward eligibility for retired pay. At this point, Rachel, you've been married for 9 ½ years. **Rachel:** Where can I find that in the law?

Attorney: The 10/10 Rule is a component of the Uniformed Services Former Spouses' Protection Act. That is found at Title 10, U.S. Code, at Section 1408 (d)(2). **Rachel:** I hear that this is a big deal for my husband. He wants to drag out the divorce until we've been married for ten years, and I already have a total of 15 years of Reserve service – so that means he would meet the requirements of the Rule if he can just get the court to slow things down for another six months. Why is he insisting on waiting for another half-year before the divorce?


Welcome to 2023! This has been an amazing year for the AAML Foundation, and I am happy to report on our activities for 2022 and to give you a sneak peak at our future plans.
