CHILDREN ARE GROWING UP IN THE CONTEXT OF A NEW PARADIGM: GENDER DOES NOT COME IN JUST TWO BOXES—BOY/GIRL, BUT RATHE
AN EVER-EXPANDING VARIATION OF GENDER POSSIBILITIES—TRANSGENDER, NON-BINARY, DEMI-BOY, DEMI-GIRL, AND SO FORTH. PARENTS
ARE RAISING THESE CHILDREN, SOME OF WHOM WILL LET THE PARENTS KNOW THAT THEY THEMSELVES ARE A GENDER CREATIVE CHILD: A
CHILD WHO IS EXPANSIVE IN EITHER THE GENDER THEY KNOW THEMSELF TO BE, THE WAY THEY EXPRESS THEIR GENDER, OR BOTH. THESE
CAN BE THE BEST OF TIMES OR THE WORST OF TIMES, DEPENDING ON THE CHILD, THE FAMILY'S VALUES, AND THE CULTURE IN WHICH THEY
ARE GROWING. FOR SURE THESE ARE TIMES WHERE SOME OF THESE FAMILIES WILL BE IN CONFLICT—BETWEEN PARENT AND CHILD OR
BETWEEN PARENTS. OTHER FAMILIES WILL FIND THEMSELVES IN CONFLICT WITH THE LEGISLATIVE LAWS IN THE STATE IN WHICH THEY LIVE.

IN THE BEST INTERESTS OF THE CHILD, ALL OF THESE FAMILIES MAY FIND THEMSELVES RELYING ON THE WISDOM OF ATTORNEYS, JUDGES,
