9:00 a.m. to 10:30 a.m. - Undertakings Plus – Golan v. Saada and the Safe Return of Abducted Children. Join D.C. Fellow, Melissa Kucinski, as she explores the Hague Abduction Convention through the lens of the most recent U.S. Supreme Court Hague Abduction case, *Golan v. Saada*. This international treaty serves to promptly return abducted children to their home country. However, it is not an unlimited remedy, and in situations where there is a grave risk of harm to the child upon return, a judge has the discretion to refuse to return that child. In *Golan v. Saada*, the district court judge, upon finding a grave risk of harm to the child based on the parties' violent relationship, explored ameliorative measures to craft a safe return order. Ms. Golan argued that such an exploration of these ameliorative measures is contrary to the treaty, and the child's return should have been denied. Learn more about the Hague Abduction Convention and how it played out in this seminal court case, as well as recent updates in the case upon remand.

## Cambridge, Maryland

Downtown Cambridge. Settled in 1684, Cambridge, Maryland has served as a seat for industry and culture through the centuries. Take a walking tour of its historic streets and enjoy today's boutiques, eateries, galleries, and more.<sup>1</sup>

## Harriet Tubman Underground Railroad Visitor Center

12.1 miles away from the hotel.

One of more than 40 stops on the self-guided Harriet Tubman Underground Railroad Byway, the visitor center offers 10,000 square feet of multimedia exhibits about Tubman's early life and slavery in the area. <sup>1</sup>

#### **Richardson Maritime Museum**

2.9 miles away

This museum tells the story of Dorchester County's rich maritime history through exquisite models of traditional wooden sailing vessels designed and built in the region—from crabbing skiffs to schooners. <sup>1</sup>

## **Old Trinity Church**

9.1 miles away

Built in the late 17th century and impeccably restored in the 1950s, this tiny colonial church houses one of the area's oldest continually practicing congregations. The serene grounds are open daily and overlook a scenic creek. <sup>1</sup>

## Blackwater National Wildlife Refuge

11.6 miles away

Celebrated by wildlife watchers and photographers, the 28,000-acre refuge hosts many species, from migrating ducks and bald eagles to Delmarva fox squirrels. Drive, bike, or walk a four-mile loop through diverse natural habitats. <sup>1</sup>

## **Emily's Produce**

5.8 miles away

Run by seventh-generation farmers, Emily's sells fresh produce, beef, eggs, jams, and more. Pick your own fruits and veggies, or join in family friendly activities, like feeding time with the chickens, rabbits, and pygmy goats. <sup>1</sup>

### **Dorchester Visitor Center at Sailwinds Park**

6.4 miles away

Tour exhibits about Dorchester County at the award-winning building that sports a 100-foot-high sail. The adjacent park includes a mile-long boardwalk, beach, playground, native plant garden, and the "flying goose" fountain. <sup>1</sup>

## **Skipjack Nathan of Dorchester**

3.2 miles away

Experience history in action with a two-hour ride on a traditional wooden skipjack. Public sails generally include an oyster-dredging demonstration, for which the ship was designed. Sunset and charter cruises are also available. <sup>1</sup>
